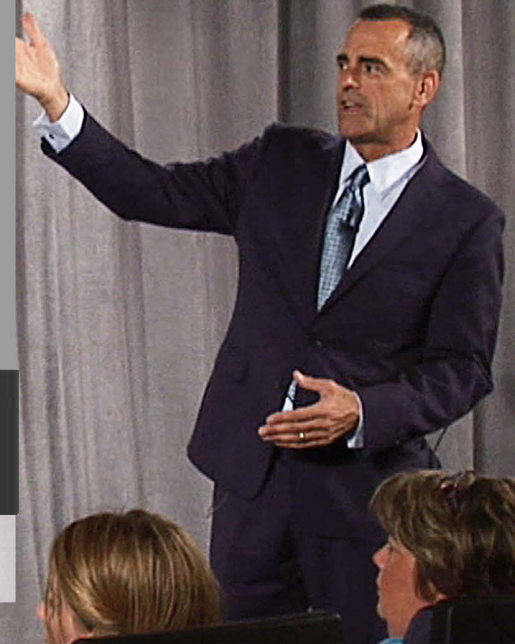

ORDINANCE NO.

**ORDINANCE AMENDING THE LATHRUP VILLAGE  
CODE OF ORDINANCES AMENDING CHAPTER 18, BUSINESSES, TO ADD ARTICLE VI,  
MARIHUANA ESTABLISHMENTS**

**The City of Lathrup Village ordains:**

**Part 1.** Chapter 18, *Businesses*, of the Code of Ordinances, City of Lathrup Village, is hereby amended to add a new Article VI, Sections 18-243 entitled *Prohibition of Marihuana Establishments*, to read as follows:

**§ 18-243. PROHIBITION OF MARIHUANA ESTABLISHMENTS**

Pursuant to the Michigan Regulation and Taxation of Marihuana Act, Section 6.1, the City elects to prohibit marihuana establishments within its boundaries, including, but not limited, any marihuana grower, marihuana safety compliance facility, marihuana processor, marihuana microbusiness, marihuana retailer, marihuana secure transporter, or any other type of marihuana-related business licensed by the State of Michigan under the Michigan Regulation and Taxation of Marihuana Act.

Pursuant to the Michigan Medical Marihuana Facilities Licensing Act, Section 205(1), being MCL 333.27205(1), the City elects to prohibit medical marihuana facilities within its boundaries, including, but not limited, any medical marihuana grower, medical marihuana processor, medical marihuana provisioning center, medical marihuana transporter, medical marihuana safety compliance facility, or any other type of medical marihuana-related business licensed by the State of Michigan under the Michigan Medical Marihuana Facilities Licensing Act.

**Part 2. Savings Clause.** This Ordinance shall in no manner affect pending litigation, either civil or criminal, founded or growing out of any ordinance, resolution, order or parts thereof, hereby repealed, and this ordinance shall in no manner affect any rights, claims, privileges, immunities or causes of action of the City, County or other person, either criminal or civil, that may have already occurred, accrued or grown out of any ordinance, resolution, order or policy, or any part thereof, hereby repealed. This Ordinance shall in no manner affect pending litigation, either civil or criminal, founded or growing out of any ordinance, resolution, order or parts thereof, hereby repealed.

**Part 3. Validity and Severability.** Should any portion of this Ordinance be found invalid for any reason, such a holding shall not be construed as affecting the validity of the remaining portions of the Ordinance.

**Part 4. Effective Date.** This Ordinance shall be effective from and after the date of its publication.

RESOLUTION EXCLUDING COMMERCIAL AND RECREATIONAL MARIHUANA FACILITIES  
AUTHORIZED PURSUANT TO THE PASSAGE OF PROPOSAL 18-1 OF 2018**

**RESOLUTION \_\_\_\_\_**

*RESOLUTION PROHIBITING THE ESTABLISHMENT OF ANY BUSINESSES OR INDIVIDUAL PROPRIETORSHIPS LOCATED WITHIN THE CITY OF LATHRUP VILLAGE FOR THE PARTIAL OR EXCLUSIVE PURPOSE OF GROWING AND/OR DISTRIBUTING RECREATIONAL MARIHUANA AUTHORIZED PURSUANT TO THE PASSAGE OF PROPOSAL 18-1 OF 2018, KNOWN AS THE "MICHIGAN REGULATION AND TAXATION OF MARIHUANA ACT OF 2018."*

WHEREAS, by passage of Proposal 18-1 of 2018, the Michigan legislature has enacted the Michigan Regulation and Taxation of Marihuana Act of 2018 to make marihuana legal under state and local law for adults 21 years of age or older, to make industrial hemp legal under state and local law, and to control the commercial production and distribution of marihuana under a system that licenses, regulates, and taxes the businesses involved; and

WHEREAS, pursuant to the Michigan Zoning Enabling Act, 2006 PA 110, the Home Rule City Act, 1909 PA 279 and the Michigan Regulation and Taxation of Marihuana Act of 2018, the City of Lathrup Village ("City") has the authority to prohibit certain uses of property and activities related to the commercial and recreational use marihuana to protect the public health, safety and welfare and in a manner consistent with the referenced Acts; and

WHEREAS, The Lathrup Village City Council has determined that it is in the best interest to protect the health, safety, and welfare of City residents to not permit any marihuana establishments as defined in the Michigan Regulation and Taxation of Marihuana Act of 2018, including marihuana grower, marihuana safety compliance facility, marihuana processor, marihuana microbusiness, marihuana retailer, marihuana secure transporter, or other type of marihuana-related business licensed by the State of Michigan, in the City of Lathrup Village; and

WHEREAS, the City wishes to declare that marihuana facilities authorized pursuant to Michigan Regulation and Taxation of Marihuana Act of 2018 are not permitted in the jurisdiction.

NOW, THEREFORE, the City Council of the City of Lathrup Village, Oakland County, Michigan resolves as follows:

THEREFORE, BE IT RESOLVED that the City of Lathrup Village declares that commercial and recreational marihuana facilities authorized pursuant to the Michigan Regulation and Taxation of Marihuana Act of 2018 are not permitted in the City of Lathrup Village and that the City Clerk is hereby directed to file a copy of this Resolution with the State of Michigan Secretary of State and Department of Licensing and Regulatory Affairs to provide notice of the declaration set forth in this Resolution.

Any and all resolutions that are in conflict with this Resolution are hereby repealed to the extent necessary to give this Resolution full force and effect.
